I hereby **DECLARE**:

That I undertake to comply with the rules and safety protocols established by the Organization of the activity, as well as to maintain a responsible behaviour that does not increase the risks to both my physical and mental integrity, or that of others. I will follow the instructions and abide by the decisions made by the leaders of the Organization in terms of organization and security.
6. That I authorize the Organization of the activity to make use of my image in any photograph, filming or recording that is made, as long as it is exclusively related to my participation in this event and to make it publicly known on the website, media and other channels, publication or brochure chosen by the Organization of the activity to publicize it, and not to receive any kind of remuneration in return.
7. That I participate voluntarily and under my own responsibility in the recreational activity, fully assuming the risks and consequences derived from my participation and, therefore, I exonerate the Organization, collaborators, sponsors and other participants from any responsibility for any physical or material damage that occurs to my person and I renounce to file a complaint or lawsuit against them.
8. That I am committed to following the general guidelines of respect for others and the environment, among others, the following:
 - Move with prudence and according to established rules.
 - Walk slowly in the presence of people, animals or vehicles.
 - Do not cause alterations in the processes and operation of the environment where the activity takes place.
 - Perform physiological needs in the right places or, in any case, out of the water and away from places where people pass through or gather.
 - Do not throw or abandon objects or solid or liquid waste outside the places expressly authorized for their collection.
